Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security amount as stated above deposited at Dharauti account No. 0170010074844 on behalf of of Shivasatakshi Municipality at Mega Bank PVT LTD, Birtamod branch or bid bond authorized from a recognized "A" class commercial bank or Finincial institution eligible to issue bank gurantee as per prevailing law of Nepal.
